PK700 TONNEAU

FABRIC CARE

All PVC fabrics require a degree of maintenance and care. General marking and mould is inevitable for outdoor fabrics, prompt attention to the affected area will minimise the chance of staining or fabric degradation.

To obtain the maximum life from your PK700 Tonneau fabric, the following points should be noted:

- 1. A regular, minimum weekly cleaning regiment with appropriate products will prolong the life of the upholstery.*
- 2. Keep the fabric clean by hosing regularly to remove dust, bird droppings and other solid particles with a suitable cloth (e.g. microfibre) or soft bristled brush and lukewarm water.*
- 3. No powered, high pressure washers to be used for cleaning fabric. *Warranty will be voided.*
- 4. Do not apply detergents, abrasive cleaners, steel wool, cleaning fluids or insecticides. These have the potential to damage the fabric surface and void the guarantee. Strictly use a mild, lukewarm pH neutral soap solution with a sponge or soft bristled brush and water only for cleaning.*
- 5. Keep petrol, oil, solvents, kerosene and other similar fluids away from the fabric.*
- 6. Do not allow bird droppings, earth, sand or vegetable matter to remain in contact with the fabric.*
- 7. Water based stains should be treated first by rinsing with cold water. If this is not sufficient, Aquatica may be washed with a mild solution of soap in lukewarm water and rinsed thoroughly. We recommend gentle brushing with a soft brush or sponge as harsh scrubbing can damage any fabric coating.*
- 8. Remove soapy residue with microfibre cloth and clean water.*
- 9. Dry thoroughly with dry microfibre cloth.*
- 10. It is important that PK700 Tonneau fabric is left to dry after wet weather and should not be rolled up or stowed away when wet.*

PK700 TONNEAU ® 7 YEAR LIMITED WARRANTY

WHAT IS COVERED?

This warranty covers PK700 Tonneau for the following:

- 1. That it will be free from visible manufacturing defects*
- 2. It is manufactured to its published specifications*
- 3. That it will not become non-functional due to loss of dimensional stability from exposure to conditions including sunlight and other normal atmospheric conditions.*
- 4. That it will not exhibit cracking (polymer breakdown) and delamination*
- 5. This warranty does not cover gradual fading, discolouration from atmospheric pollution, mould or other debris. Abnormal or excessive fading is covered.*
- 6. There is a reduced warranty of 5 years for colour fastness on bright colours (especially those including a red pigment)*
- 7. Paskal must be notified in writing (before fabrication or installation of the material) within 30 days of any defects found with regard to fabric configuration, dimension, strength or colour that exist at the time of initial delivery.*

HOW LONG IS THE COVERAGE PERIOD?

The warranty coverage runs for 7 years from the date of purchase.

WHAT WILL PASKAL, THE DISTRIBUTOR FOR PK700 TONNEAU DO?

Paskal will provide new fabric, at no cost, to replace the non-functioning fabric. This warranty does not cover the cost of labour or other consequential or incidental expenses. This warranty can only be enforced against presentation of the original installers invoice showing fabric reference and colour as well as date of assembly. The warranty is not transferable and applies only to the original purchaser

The liability of Paskal is limited under this warranty to replacement or refund of the original purchase price of material only on a prorated basis of time in use The liability of Paskal is limited under this warranty to replacement or refund of the original purchase price of material only on a prorated basis of time in use i.e. 1st year 100%, 2nd year 90%, 3rd year 80%, 4th year 70% and 5th year 60%, 6th year 50% and 7th year 40%.

The correct care procedures (as outlined above) must be followed to ensure that every step has been taken to maintain the PK700 Tonneau fabric.

PASKAL WILL NOT BE LIABLE FOR ANY CLAIM UNDER THIS WARRANTY IF ANY OF THE FOLLOWING APPLY.

- 1. The defect has been caused by improper use of the fabric and or for any purposes other than it has been designed.*
- 2. If the fabric has been subject to misuse, neglect or abuse.*
- 3. The fabric was not maintained in accordance with the published care & maintenance guide.*
- 4. The fabric has been altered or modified in any way unless such modification has been approved in writing by Paskal.*
- 5. If the fabric has not been fabricated by a qualified tradesman or to a reasonable standard of workmanship.*
